**Call for Nominations:
Vice President with responsibility for Business, Industry and Government Engagement
2025 – 2026 term**

Nominations are invited from Honorary Fellows, Fellows and Members, to fill the above position on the IMA Council from 1 January 2025, for an initial term of two years. Vice Presidents may serve for a maximum of four consecutive years.

As well as attending three Council meetings per year, as an Honorary Officer of the IMA, Vice Presidents are expected to play an active role in promoting or developing some aspect of the Institute's mission "to promote mathematics in research, education, industry, commerce and the public sector". In their personal statement, Candidates should indicate the qualities and attributes they can bring to the role. The IMA seeks to be a member driven organisation with Council representation from all sectors of the membership. We particularly encourage nominations from women, from those working in industry, and from those based in Scotland, Wales and Northern Ireland.

Nominations may be submitted up to 10 October 2024, and the final selection will be made by our Council on 27 November 2024.

If you believe you can support the IMA in this important role, may I ask you to give serious consideration to stand or to nominate as the future well-being of the Institute relies on the involvement and contribution of members of Council and its Officers.
